Again, that is **ONE TIME ONLY**. This is to ensure that many families in need are able to benefit from the Xtreme Couture GI Foundation and not just a handful.

All incomplete applications will not be processed. **You must have completed the entire application, DD214/ CURRENT ACTIVE DUTY LES, any supporting documents to your financial snap shot and any submission of photos or videos must accompany the application and will not be accepted separately.**
